DUTIES AND LIABILITIES OF COMMITTEE MEMBERS

- 1. SCCC is incorporated as a registered society under The Co-operative and Community Benefit Societies Act 2014.
- 2. The duties imposed on company directors by the Companies Act 2006 do not cover members of the committee of a registered society. However, the members of the committee of management of a registered society, being persons appointed to manage the business and affairs of the society, are accountable in the same manner as company directors under the general law of agency. As a result they will owe a duty of care and certain fiduciary duties.
- 3. The following duties are derived from the law of agency as well as the obligations imposed on company directors under the Companies Act 2006. It is possible that they are stricter than would in law be required of a committee member of Surrey CCC, but they represent best practice for officers of the Club.

4. Duties:

The duties to be complied with by committee members are:

- To act within their powers as conferred by the Rules of the Club or as delegated to them:
- To promote the success of the Club and to act in good faith in the best interests of the Club:
- To exercise independent judgement;
- To exercise reasonable care, skill and diligence;
- To avoid conflicts of interest;
- To declare any interest in a proposed transaction or arrangement with the Club.

Committee members should register any benefits received from their parties in the course of their duties for Surrey County Cricket Club in accordance with its Anti Bribery and Corruption Policy.

Members of the General Committee are covered under the Club's sport governance insurance policy for costs in the event of legal action up to a maximum of £1m. A copy of the policy is available upon request.

General Guidelines for Candidates wishing to stand for General Committee Election

- 1. All candidates must be a member of Surrey County Cricket Club. Their nomination must be supported by five other members of the Club.
- 2. Completed application forms must be returned to the Club prior to 1st February 2022.
- 3. The details submitted in your application will be reproduced as faithfully and as practically possible and distributed to members with voting papers prior to the 2022 AGM.
- 4. If elected, General Committee members are required to attend General Committee meetings a minimum of six a year are held.
- 5. General Committee members are required to comply with ECB Directives and, if contravening them, may cause Surrey CCC to be subject to disciplinary proceedings. A copy of ECB's Directives and Disciplinary Regulations will be issued once nomination forms have been submitted.
