Surrey County Cricket Club: Boys and Girls U10 to U18 Assessment Application Process

Introduction

Outlined below is information, terms and conditions that apply to the Boys and Girls U10 to U18 Assessment Application Process, which allows users of the scheme the opportunity to submit video content and personal details to Surrey County Cricket Club (SCCC thereafter), for review by coaches at SCCC, demonstrating their skills as a batter, bowler or wicket keeper.

Videos submitted will be viewed by the SCCC Pathway staff who will be assessing each submission based on a range of technical criteria.

Successful applicants will be invited to a Phase 2 assessment along with other Pathway cricketers in the period September-December 2023 and will be informed of further engagement by email on or before Friday 15th September 2023.

Unsuccessful applicants will receive skillset feedback based on our 'Surrey ID'. This will outline what attributes our coaches are looking for in a SCCC Pathway cricketer.

Dates

Entries can be submitted between Thursday 1st June 2023 and Tuesday 1st August 2023.

Who is Eligible

The scheme is open to players in academic years 5 to 13 (from September 1st 2023) to submit their personal details and video content. All individuals submitting content must have the permission of their parent or guardian.

To qualify to engage in the Surrey CCC Performance Programme you must either; Live in Surrey/Go to School in Surrey/Be registered at a Cricket Club within Surrey.

You must possess a British Passport, or have proof of Permanent Leave to remain in the United Kingdom.

Members of 2023 Performance squads in the U10 to U18 age groups NEED NOT APPLY. These players will be invited onto winter programmes (or not) based upon their recent development through the summer match-play season. Some players maybe be requested to attend a Phase 2 assessment before a decision is made on future involvement.

How to submit

Submissions must be made via WhatsApp via the details provided:

Boys U10 - U18 (years 5 to 13) – 07300 330 097

Girls U10 - U18 (years 5 to 13) – 07300 330 103

The receiving devices are owned by SCCC, and the WhatsApp accounts are registered as business accounts.

CALLS TO THESE NUMBERS WILL NOT BE ANSWERED – these numbers are linked to WhatsApp data gathering only.

On completing your submission, you will receive an automated response from SCCC informing you that your submission has been successful, and this response will include a consent and data protection form which must be completed to confirm the application.

Use of video content, personal details, and data

Videos will be reviewed by SCCC coaches on a secure device and server by SCCC staff. All SCCC staff reviewing submissions are DBS checked and safeguarding trained.

Coaches will review submissions during August/September 2023. After this point, successful entries will be contacted via email informing them of their successful entry and the next steps in the scheme, should they wish to continue.
